### 2018 Community Economic Development Award Recipients

#### Population less than 10,000

#### **Development Corporation of Haskell**

The Development Corporation of Haskell (DCOH), facing the loss of 150 jobs at a local Immigration and Customs Enforcement (ICE) facility, sprung into action to save the facility from closing immediately. The lobbying efforts of the DCOH and the County Judge helped keep the facility from closing for a year after the announced shutdown. After the ICE facility closed, the DCOH worked to bring in LaSalle Corrections, a jail management company. Eventually, LaSalle purchased the former ICE facility. That facility now houses 550 inmates and 160 employees. Payroll will exceed \$105 million over the next ten years and total economic impact in Haskell and the surrounding area will exceed \$208 million.

#### Population 10,001 to 20,000

#### Sulphur Springs-Hopkins County Economic Development Corporation

The Sulphur Springs-Hopkins County Economic Development Corporation spearheaded a complex, multifaceted project that included the purchase of land from one major industry to support the expansion of another, the use of a Texas Capitol Fund grant to upgrade the city's wastewater pre-treatment plant, and, working with Oncor to acquire a site for the expansion of a major Sulphur Springs industry. Eventually, the land purchase and infrastructure improvements led to an expansion of 61 jobs at Saputo, a major specialty foods manufacturer. An ancillary part of the land acquisition process enabled one of Sulphur Springs' oldest employers, JB Weld, to build a new 78,000 square foot facility while also adding 13 new jobs.

#### Population 20,001 to 50,000

#### City of Greenville and Greenville Board of Development

The City of Greenville and the Greenville Board of Development worked with Solvay/Cytec Corporation on a \$10 million capital investment expansion of their plastics resin mixer plant. The project was in competition with five other US-based sites and several overseas operations. Local taxing authorities granted tax abatements via the state's Chapter 311 and 312 statutes. The facility expansion will create 40 new jobs. Longer term, and as the result of the community's involvement in the expansion, Solvay Greenville is in consideration for an additional \$60 million future expansion.

#### Population 50,001 to 100,000

#### Waller County Economic Development Partnership

The Waller County Economic Development Partnership attracted M.A.N. Energy Solutions, a Germanbased manufacturer of maritime engines, M.A.N. chose a 16-acre site in a new master-planned, mixed-use development. The 132,000 square foot facility will employ 142 full-time employees with an average annual salary of over \$100,000.

#### Population 100,001 to 250,000

#### Tyler, Lindale and Mineola

The Tyler Economic Development Council, the Lindale Economic Development Corporation and the Mineola Economic Development Corporation combined forces to attract a \$200 million, 1,700 employee Sanderson Farms poultry processing facility. The investment included a \$130 million processing facility, an administrative office and hatchery, a feed mill, and a contract with 80 local famers to invest another \$130 million to grow chickens in the region. The three economic development organizations along with the counties of Smith and Wood put together an incentive package in excess of \$52 million that included free land, tax abatements and infrastructure grants. The ten-year economic impact of this project will be \$1.45 billion for the local and regional economies.

#### Population 250,001 and Above

#### San Antonio Economic Development Foundation

The San Antonio Economic Development Foundation worked with USAA, a company that started in San Antonio in 1922, to add 1,500 new employees downtown, bringing the number of USAA employees in downtown San Antonio to more than 2,000. The move represents the most significant investment in downtown San Antonio in many years and jumpstarts the opportunity to reshape downtown development. The City of San Antonio provided a \$4 million economic development loan and up to \$2 million in tax abatements for Improvements made with the purchases by USAA of One Riverwalk Plaza and America Financial Services Center. USAA is investing \$70 million in improvements to those two buildings and the \$1,500 new jobs will average over \$50,000 per year.
