WHEREAS, by an Order of Sale issued out of the 402<sup>nd</sup> Judicial District Court of Wood County, Texas; in Cause No. T-3854 styled Mineola Independent School District, et al, vs. Jeffery Simmons, deceased and the unknown heirs of Jeffery Simmons, et al, and delivered to the Sheriff directing him to seize, levy upon and sell the hereinafter described property to satisfy the amount of all delinquent taxes, penalties, interest and costs which were secured by a judgment rendered in said cause on the 30th day of May, 2017, in favor of the Plaintiffs.
