"I am a competitor," summarized Mineola High School basketball standout Sabria Dean, "and I love winning even more than I hate losing." Dean had just been named the Tyler Morning Telegraph's All East Texas Player of the Year, and she took a moment to describe her perspective on basketball.

A three-year starter for the Lady Jackets, Dean is primed to make her senior season with the squad a historic one. After a deep play-off run last year, the Lady Jackets return all their starters and are looking to compete for that elusive state championship.

The competitive fire burning inside Dean developed courtesy of many young male relatives who grew up with the young star playing hoops in the community. She described learning how to be competitive, tough and to never back down.

The origins of her style of play are obvious to anyone who watches her compete today. She plays the game hard, leads from the front, and wins the overwhelming number of small individual battles within each game.

Those skills were instilled early by her mother, Sabrina Dean, who coached her daughter until organized basketball took over. An athlete herself, Sabrina

That early investment shaped more than just athletic skill in Sabria. She evolved into a perfectionist and can readily relate episodes involving individual teachers in primary school who helped developed that trait. She continues to hone her basketball skills through the summer Texas Elite League. The two months of tournament play will take her to Indianapolis and Atlanta as her Dallas-based team, "Prime," faces the best in national high school basketball talent.

"The Elite League is great because it is as fast-paced as college ball and improves one's physicality." Dean explained. She also admitted that small tweaks in her game, especially in her jumpshot, are realized through this competition.

Her efforts are being noted. A long list of universities have expressed interest in her. Two specific offers Dean.

Dean excelled as a sprint- have already been received with more expected. In addition to playing hoops collegiately, Dean will pursue a degree in occupational therapy.

There is yet a long senior season ahead. The Lady Jackets will be under new leadership as Brad Gibson will be taking over as head coach having come down Highway 69 from Lone Oak High School. Previous Lady Jacket coach Tony Riley has moved on to Tyler John Tyler High School.

Dean doesn't expect the aggressive playing style of the Lady Jackets to change ... only to get better. "We will definitely press and create the turnovers and attack," she stated. After describing last year's campaign as an unbelievable experience, she admitted that the team is ready to "tear it up" in 2019. 
