Dear Mr. Hicks:

On September 3, 2019, the Texas Commission on Environmental Quality (TCEQ) received your corrosivity engineering report as requested in our well use approval letter dated December 8, 2016 (P-10102016-042). Based on our review, the report generally meets the minimum requirements of Title 30 Texas Administrative Code (TAC) Chapter 290 - Rules and Regulations for Public Water Systems and is accepted.

The submittal consisted of a corrosivity engineering report with the following information:

- 40 sites tested July 2017 and March 2017 with no copper results exceeding 1.3 mg/l and no lead results exceeding 0.015 mg/l.
- Will continue addition of blended ortho/polyphosphate (NAPCO 214) with a new target dose of 1.0 -2.0 mg/l (previously 0.5 - 1.0 mg/l).

The City of Mineola public water system provides water treatment.
