Background Information:

The police department has in the past experienced a high turnover rate, and often times invested many hundreds of dollars into specialized training for officers who then leave for another department.

Speaking with Blake Armstrong, City Attorney, he stated that we are well within our rights to ask that if the city provides training for an officer (or any employee), that that employee sign an agreement to stay employed for a minimum of 24 months, or reimburse the city for the cost of the training, unless discharged by the city. This is one attempt to retain employees and lessen the worry of providing costly training for someone who isn't planning on a career in Mineola.

This contract was reviewed and approved by Blake.

Recommendation:

It is recommended that the Council approve allowing the city to begin using the agreement.
