## ORDINANCE NO. 20-04-27

At the regular City Council Meeting of the City Council of the City of Mineola, Wood County, Texas, held on April 27, 2020, at 5:30 p.m., at the Mineola Municipal Complex, there being a quorum of the City Council present, upon motion duly made and seconded the following Ordinance was adopted, to-wit:

WHEREAS, the City Council has received information regarding the benefits of annexing the roadway right of way of Loop 564; and

WHEREAS, the City Council now wishes to formalize this annexation by its authority granted under Section 43.1055 of the Local Government Code.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MINEOLA, TEXAS:

## SECTION 1.

A depiction of the right-of-way being annexed by way of this ordinance is attached hereto as Exhibit "A".

The right-of-way and roadway annexed herein is 2,388.62 linear feet and totals 8.00 acres. A more specific legal metes and bounds description of the property being annexed can be found in the attached Exhibit "B".

Once annexed, all utility work within the right-of-way listed in this section will be required to go through Texas Department of Transportation (TxDOT) standard utility permitting process.

## SECTION 2.

The city secretary is hereby directed to file with the County Clerk and other appropriate officials and agencies, as required by state and federal law and applicable annexation procedures, a copy of this ordinance.

## SECTION 3.

Should any section of this ordinance be held unconstitutional, illegal or invalid, such finding shall not affect, impair or invalidate the annexation of any other property or portion of property which is included in and subject to this annexation ordinance.

## SECTION 4.

This Ordinance shall be effective immediately upon its passage and approval by the City Council for the City of Mineola, Texas.

THENCE South 88 Degrees 36 Minutes 40 Seconds West, with the South right-of-way of Loop 564, a distance of 461.68 feet to a Concrete Monument found at the beginning of a curve to the left, with a radius of $1,702.95$ feet, a delta angle of 14 Degrees 17 Minutes 48 Seconds, the chord of which bears South 81 Degrees 30 Minutes 11 Seconds West, for a chord distance of 423.83 feet;

THENCE North 76 Degrees 37 Minutes 45 Seconds East, with the North right-of-way of Loop 564, a distance of 208.78 feet to a Concrete Monument found at the beginning of a curve to the right, with a radius of $1,822.95$ feet, a delta angle of 14 Degrees 13 Minutes 13 Seconds, the chord of which bears North 81 Degrees 31 Minutes 25 Seconds East, for a chord distance of 451.28 feet

THENCE with the North right-of-way of Loop 564, along the arc of said curve, for an arc length of 452.44 feet to a Concrete Monument found;

THENCE North 88 Degrees 39 Minutes 19 Seconds East, with the North right-of-way of Loop 564, a distance of 361.15 feet to a Concrete Monument found;

THENCE North 82 Degrees 45 Minutes 50 Seconds East, with the North right-of-way of Loop 564, a distance of 100.23 feet to a Concrete Monument found;

THENCE North 88 Degrees 33 Minutes 34 Seconds East, with the North right-of-way of Loop 564, a distance of 201.09 feet to a Concrete Monument found;

THENCE South 88 Degrees 29 Minutes 25 Seconds East, with the North right-of-way of Loop 564, a distance of 199.30 feet to a Concrete Monument found;

THENCE North 88 Degrees 34 Minutes 50 Seconds East, with the North right-of-way of Loop 564, a distance of $1,335.92$ feet to a point for the Northeast corner of this 8.00 acre tract and the most Westerly Northwest corner of said 10.252 acre tract, from which a Concrete Monument found bears, North 88 Degrees 34 Minutes 50 Seconds East, a distance of 165.04 feet and a $1 / 2$ inch iron pipe found bears, South 88 Degrees 34 Minutes 50 Seconds West, a distance of 1.56 feet;
