CALL TO ORDER Mayor White called the meeting to order at 5:30 p.m. and confirmed a quorum

of the council was present.

Invocation led by Kevin White and Pledge of Allegiance lead by Greg Hollen

CITIZEN COMMENT – Mr. G. Waters of 1721 Country Club Drive in Mineola addressed the council regarding his concerns about a property next door to him. The property appears to have multiple code violations that are affecting his property and he asked the city to address these. He also requested that the city consider abandoning the alley that runs next to his property as it is not currently in use.

6. Discuss and consider action on a resolution designating Carol Taylor and Angela Luman as agents to calculate the no-new revenue tax rate and the voter approval tax rate.

Mrs. Karch informed the council that this was a new requirement of SB-2. Councilmember Jayne Lankford made the motion to adopt the resolution. The motion was seconded by Councilmember Sue Jones and carried by a unanimous roll-call vote.

7. Discuss and consider action on a preliminary plat for Blackmon Meadows.

Fire Marshal David Madsen explained that this plat is for the new subdivision recently annexed by the City. Councilmember Jayne Lankford made the motion to approve the plat. The motion was seconded by Councilmember Greg Hollen and carried by a unanimous roll-call vote.

8. Discuss and consider action on high bid received for sale of city property on Hogg and Buchannan St.

Two bids were received for the property; Jensco Investments for \$5,000 and Jeff Sandifer, LLC for \$12,001. City recommends accepting bid from Jeff Sandifer, LLC. Councilmember Sue Jones made the motion to accept the bid. The motion was seconded by Councilmember Mitchell Tuck and carried by a unanimous roll-call vote.
