CALL TO ORDER Mayor White called the meeting to order at 5:30 p.m. and confirmed a quorum

DISCUSSION ON ACTION ITEMS, PUBLIC HEARINGS, PRESENTATIONS AND ANNOUNCEMENTS

10. Discuss Meredith Requests for 2021, requests due by November 13th for November meeting.

Mrs. Rushing asked the council to submit projects they would like to consider for the Meredith Grant. Submitted projects from council and department directors will be scored by priority and brought back to council for final approval.

11. Presentation of Year End Financial Reports by Cindy Karch/Finance Director.

Mrs. Karch presented the yearend financial highlights to the council.

12. Discuss and consider action on an ordinance adopting a Social Media Policy.

Mrs. Lynn Kitchens informed the council that the Social Media Policy was in addition to the current Social Media Policy within the handbook. This new policy will become an ordinance and will help guide staff on managing social media pages for the city and establish a code of conduct for anyone posting on city social media sites. She also discussed the following Digital Media Policy, which will determine how city websites and other digital media are managed.

Councilmember Polly Jones made the motion adopt Ordinance 20-10-26-13. The motion was seconded by Councilmember Jayne Lankford and carried by a unanimous roll-call vote.

14. Discuss and consider action on adopting the updated City of Mineola Safety Policy and Program, first established November 25, 2002.

Councilmember Cassandra Sampson made the motion to adopt the policy. The motion was seconded by Councilmember Jayne Lankford and carried by a unanimous roll-call vote.

15. Discuss and consider action to solicit bids on city owned property, Lot 2D, Blk E, City of Mineola, located on Harris St.

Councilmember Mitchell Tuck made the motion to solicit bids on city property, Lot 2D Blk E City of Mineola, located on Harris St. The motion was seconded by Councilmember Sue Jones and carried by a unanimous roll-call vote.

Mrs. Rushing introduced new employee Lisa Morrison. Lisa is the new Court Clerk and Assistant City Secretary and comes with many years of city experience. Doris Newman has been working with small businesses to help them apply for the many grants available to them. Gene's Photography was awarded one of these grants and are using the funds to restore and remodel their building. Out of 67 grants awarded nation-wide, only three were awarded in Texas, Gene's being one. Rotary club will be offering county-wide recycling for electronics November 14th from 9am to 1pm at the Mineola Methodist Center on Newsom St. The new City of Mineola advertising promotion video first aired in the Mineola-Pottsboro gam and has over 10.3k views. Daylight savings ends the first weekend in November. Election Day will be at City Hall and Mineola Methodist Center November 3rd. Mineola Farmers Market last day will be November 21st from 8am to 1pm. City Hall will be closed November 11th for Veterans Day and November 26th and 27th for Thanksgiving. Councilmember Jayne Lankford mentioned that the Mineola First Responders won a softball tournament over the weekend. The tournament raised funds for the East Texas Crisis Center.

There being no further items for consideration, a motion to adjourn was made and the meeting adjourned.
