Recommend award bid to Mario A. Turcios in the amount of \$800.

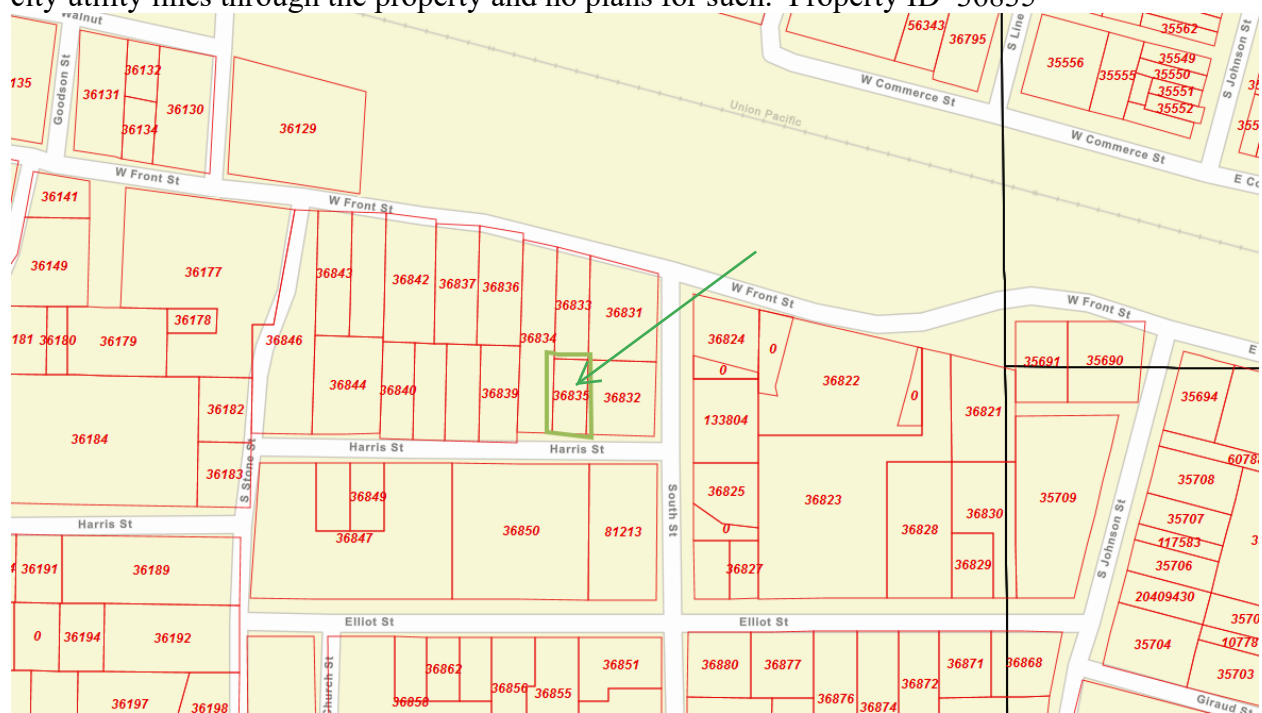

It is recommended that the city place this property for bid.

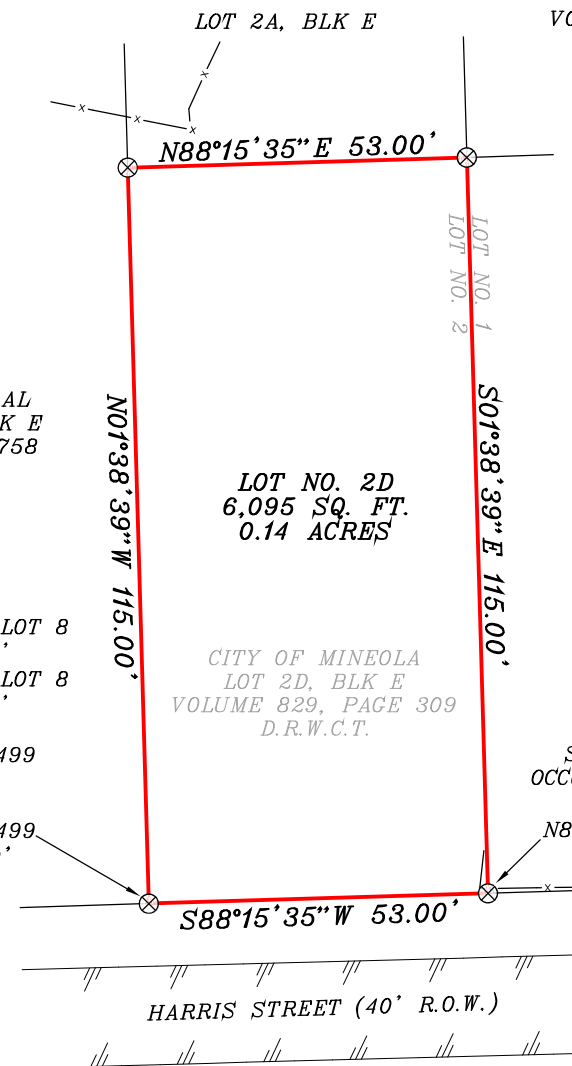

LEGAL DESCRIPTION

Being a lot, tract or parcel of land situated in the E. Evans Survey, Abstract No. 192, Wood County, Texas, and being all of that certain tract of land conveyed from the Estate of Ima Jones to The City of Mineola, by Warranty Deed, as recorded in Volume 829, Page 309, Deed Records, Wood County, Texas, and also being known as Lot No. 2D, Block E, City of Mineola, and being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2 inch iron rod set with cap stamped (BY-LINE) at the Southeast corner of said Lot No. 2D, the Southwest corner of Lot No. 1B, Block E, conveyed to Noel Martinez, by deed as recorded in Volume 1786, Page 880, Real Property Records, Wood County, Texas, the Southeast corner of Lot No. 2, Block E, City of Mineola, per plat recorded in Volume 007, Page 051, Plat Records, Wood County, Texas, and the Southwest corner of Lot No. 1, Block E, said point being in the North line of Harris Street, (40' R.O.W.), from said point, a steel post found at the occupied Southeast corner of said Martinez tract, and the occupied Southeast corner of said Block E, bears North 88 Degrees 15 Minutes 35 Seconds East, a distance of 107.36 feet;

THENCE, South 88 Degrees 15 Minutes 35 Seconds West, with the South line of said Lot No. 2, and the North line of said Harris Street, a distance of 53.00 feet to a 1/2 inch iron rod set with cap stamped (BY-LINE) at the Southwest corner of said Lot No. 2D, and the Southeast corner of Lot No. 2C, Block E, conveyed to Santos Turcios et al, by deed as recorded in File No. 2020-0000758, Official Public Records, Wood County, Texas, from said point, a 1/2 inch iron rod found with a plastic cap stamped (HOOKER) in the East line of Lot No. 8, Block E, bears South 59 Degrees 23 Minutes 29 Seconds West, a distance of 302.81 feet, another 1/2 inch iron rod found with a plastic cap stamped (HOOKER) at the Northeast corner of said Lot No. 8, bears South 79 Degrees 39 Minutes 18 Seconds West, a distance of 268.02 feet, a 5/8 inch iron rod found at the Northeast corner of a called 1.10 acre tract conveyed to Brandon Martin et ux, by deed as recorded in File No. 2018-00010499, Official Public Records, Wood County, Texas, bears South 73 Degrees 55 Minutes 12 Seconds West, a distance of 161.51 feet, and a 1/2 inch iron rod found at the Northwest corner of said 1.10 acre tract, bears South 82 Degrees 53 Minutes 00 Seconds West, a distance of 426.90 feet;

THENCE, North 01 Degrees 38 Minutes 39 Seconds West, with a common line to said Lot Nos. 2D and 2C, a distance of 115.00 feet to a 1/2 inch iron rod set with cap stamped (BY-LINE) at the Northwest corner of said Lot No. 2D, and the Southwest corner of Lot No. 2A, Block E;

THENCE, North 88 Degrees 15 Minutes 35 Seconds East, with a common line to said Lot Nos. 2D and 2A, a distance of 53.00 feet to a 1/2 inch iron rod set with cap stamped (BY-LINE) at the Northeast corner of said Lot No. 2D, the Southeast corner of said Lot No. 2A, the Southwest corner of Lot No. 1A, Block E, once conveyed to Joe Ardis, by deed as recorded in Volume 636, Page 819, Deed Records, Wood County, Texas, and the Northwest corner of said Lot No. 1B, said point being in the East line of said Lot No. 2, and the West line of said Lot No. 1;

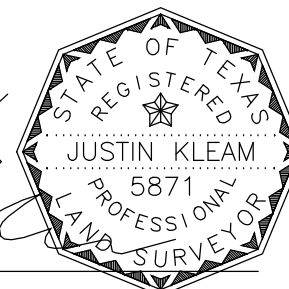
THENCE, South 01 Degrees 38 Minutes 39 Seconds East, with a common line to said Lot Nos. 2D, 1B, 1, and 2, a distance of 115.00 feet to the POINT OF BEGINNING and CONTAINING 6,095 square feet or 0.14 acres of land.

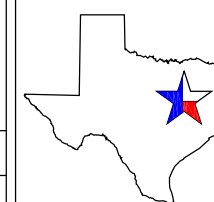
