

ORDINANCE _____

AN ORDINANCE AMENDING SECTION 34-22 OF THE CODE OF ORDINANCES OF THE CITY OF MINEOLA, TEXAS,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MINEOLA, TEXAS, AS FOLLOWS:

Section 34-22 of the Code of Ordinances, City of Mineola, Texas, is hereby amended to read as follows, to-wit:

Section 34-22. Service rates - Schedule

(a) The rates for residential solid waste collection inside the city limits shall be eighteen dollars and sixty-three cents (\$18.63) per month for a residential dwelling and the solid waste shall be placed behind the curb or in the alley where accessible. This rate includes brush and leaf pick-up.

(b) The rate for residential solid waste collection outside the city limits shall be sixteen dollars and thirty-five cents (\$16.35) per month, and all regulations and definitions for inside the city limits shall also apply to customers outside the city limits. This rate does not include brush and leaf pick-up.

(c) The rates for commercial handload solid waste collection inside and outside the city limits shall be as follows:

| # of 30 Gal Bags | 1 pickup per week | 2 pickups per week | 3 pickups per week |
|------------------|-------------------|--------------------|--------------------|
| 1 to 5 | \$19.12 | \$28.97 | \$56.85 |
| 6 to 10 | \$28.97 | \$41.63 | \$82.15 |
| 11 to 15 | \$41.63 | \$64.98 | \$109.78 |

The rates shall be effective for the July, 2021 billing period.

In accordance with provisions in our contract Amendment for Solid Waste Collection & Disposal with the City of Mineola under RATES please accept this letter as your required notification from Republic Services of the 3% rate adjustment. (This represents a .32 cent per month increase per residential unit charged to the city \$11.17). Commercial Handload rates will also reflect 3% on the matrix rate sheet. The effective date of said adjustment shall be July 1, 2021. Please note that Commercial dumpster rates are not affected. This is the first residential rate change since 2018.

This annual adjustment was approved at the execution of the current solid waste contract Amendment by council and will not require any further action with the exception of a new ordinance for new rates passed on to the City's customers.

I have attached a new rate sheet for your approval. Please look over these carefully and let me know if there are any corrections. We sincerely appreciate the city of Mineola.
