ORDINANCE NO. 20-06-28-

AN ORDINANCE AMENDING THE BUDGET FOR THE CITY OF MINEOLA, TEXAS, FOR THE FISCAL YEAR OCTOBER 1, 2020 THROUGH SEPTEMBER 30, 2021.

WHEREAS, an annual operating budget for the fiscal year October 1, 2020 through September 30, 2021, was approved and adopted by the City Council of the City of Mineola, Texas on September 14, 2020; and

WHEREAS, said full and final consideration of said budget amendment have been held in a legally posted public meeting of the Mineola City Council, and it is the consensus of opinion that the budget amendment as submitted, should be approved and adopted.

SECTION I

The City Council for the city of Mineola, Texas, does hereby ratify, adopt and approve the budget amendment as itemized in the attached Exhibits for the fiscal year beginning October 1, 2020 through September 30, 2021.

SECTION II

A true and correct copy of the Amended Budget is hereby directed to be filed in the office of the City Secretary, and said Amended Budget is made part of this Ordinance by reference as though fully copied herein verbatim.

SECTION III

The City Manager is hereby authorized to make intra-departmental and inter-departmental fund transfers within a fund during the fiscal year as becomes necessary in order to avoid the over-expenditure of a particular object code or department.

SECTION IV

All ordinances or parts of ordinances found to be in direct conflict with this Ordinance are hereby repealed to the extent of the direct conflict only.

SECTION V

It is being deemed by the City Council that this Ordinance shall go into immediate effect and force after its passage, approval and publication according to law.
