# **Background Information:**

This ordinance will make the following changes:

Commercial Plan Review was 25% of permit fee, changed to \$0.0625 per sq. ft.

Reinspection Fees, first reinspection changed from \$49.50 to \$50.00

All other fees remain the same. Justin looked at other cities and found that we were in line with those around us.

However, there are still some references to the old fee structure that was based on valuation. This ordinance should remove all of those references.

AN ORDINANCE OF THE CITY OF MINEOLA AMENDING SECTION 8-5 AND SECTION 8-6 OF THE CITY OF MINEOLA CODE OF ORDINANCES, AMMENDING PERMIT AND INSPECTION FEES FOR BUILDING CONSTRUCTION, PLUMBING, ELECTRICAL, MECHANICAL AND OTHER CONSTRUCTION OR MAINTENANCE AND REPAIR OF SUBCOMPONENTS OF CONSTRUCTION; PROVIDING FOR SUPPLEMENTAL AND CUMULATIVE PROVISIONS; PROVIDING FOR A REPEALER CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Mineola, Texas had duly adopted various building, plumbing, electrical, mechanical and other construction or maintenance and repair of subcomponents of construction codes as authorized by the State of Texas; and,

WHEREAS, the City Council of the City of Mineola has the authority to establish permit and inspections fees for the various codes adopted by the City of Mineola and/or required by the laws of the State of Texas and the City Council of the City of Mineola has determined by City Ordinance that said fees may be amended from time to time by Ordinance;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Mineola, Wood County, Texas:

# SECTION 1 AMENDMENTS

The following Selections of Chapter 8 (Building and Building Regulations), Article I (In General) is hereby amended as follows:

• Section 8-5 (Same – Amendments) is hereby amended as follows:

See Exhibit "A"

- Section 8-6 (Building permit fees) subsection (a) is hereby amended as follows:
  - (a) *Permit fees:* The permit fee schedule of permit fees is amended from time to time by ordinance. See appendix B, Fee Schedule.
- Section 8-6 (Building permit fees) subsection (c) is hereby repealed in its entirety.
- Section 8-6 (Building permit fees) subsection (d)

Delete: "Said plan review fee shall be in accordance in accordance with building valuation data as follows and shall be adjusted on an annual basis as BVD per the ICC is published and run concurrent with ICC calculations:"

## **SECTION 2**

That the heretofore described Permit and Inspection fees, more specifically described in Exhibit "A", attached to this ordinance, shall become the established fees.

#### **SECTION 3**

Provisions of this section are supplemental and shall be cumulative with all other laws and ordinances applicable in any manner to building, construction, and all other related codes.

#### **SECTION 4**

All Ordinances or portions thereof in conflict with the provisions of this Ordinance, to the extent of such conflict, are hereby repealed, but only to the extent of such conflict.

#### **SECTION 5**

If any word, sentence, clause, paragraph, or provision of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, such portions shall be deemed a separate, distinct, and independent provision, and such holding shall not effect validity of remaining portions thereof.

## **SECTION 6**

This Ordinance shall take effect after being passed and approved by the City Council of Mineola, Texas and as otherwise required by law.
