SUBJECT: Budget Amendment FY 2023 Budget

Background Information:

Despite careful planning and budgeting, the total expenses for the purchase of the two fire trucks and Park Central Street construction exceeded the tax revenue note issued in 2023. Combined costs came in over budget by \$747,700.06.

Because both items are critical for our community and infrastructure, I propose a transfer from the General Fund to the Fire Department Capital Fund to cover the remaining cost of the two trucks. The attached budget amendment will acknowledge that the council approves of this transfer.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MINEOLA, TEXAS AMENDING THE 2023 BUDGET EXPENDITURES FOR FISCAL YEAR ENDING SEPTEMBER 30, 2023; AUTHORIZING EXPENDITURES AS SET OUT IN SUCH BUDGET AMENDMENT AND PROVIDING FOR EFFECTIVE DATE

WHEREAS, the City Council of the City of Mineola, Texas, adopted Ordinance No. <u>22-09-19-2 on September 19, 2022</u>, approving expenditures for the fiscal year ending September 30, 2023 pursuant to the laws of the State of Texas; and

WHEREAS, it is necessary to amend the 2023 budget.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MINEOLA, TEXAS:

- **Section 1**. The appropriation amounts of the official budget of the City of Mineola for the fiscal year ending September 30, 2023 are hereby amended as described below:
- **Section 2**. To provide for line-item adjustments as necessary.
- **Section 3**. The amendments to authorized appropriations for the fiscal year ending September 30, 2023, are summarized in Exhibit "A", hereto attached.
- **Section 4.** The City Manager is hereby authorized to make intra-departmental and inter-departmental fund transfers within a fund during the fiscal year as becomes necessary in order to avoid the over-expenditure of a particular object code or department.
- **Section 5.** A true and correct copy of the Amended Budget is hereby directed to be filed in the office of the City Secretary and said Amended Budget is made part of this Ordinance by reference as though fully copied herein verbatim.
- **Section 6.** It is being deemed by the City Council that this Ordinance shall go into immediate effect and force after its passage, approval, and publication according to law.
