#### ORDINANCE NO.

### AN ORDINANCE OF THE CITY COUNCIL FOR THE CITY OF MINEOLA, TEXAS ABANDONING A PORTION OF THE CITY'S RIGHT OF WAY LOCATED WITHIN THE CITY LIMITS OF MINEOLA, TEXAS

**WHEREAS**, it has been requested that the City of Mineola, Texas abandon a portion of its right of way located within the city limits of Mineola, Texas.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council for the City of Mineola, Texas as follows:

1. Certain owners of real property have petitioned City to abandon a portion of the City's right of way in an alleyway further described in the Petition To Close Alleyway which is attached hereto as **Exhibit "A"**; and

2. That said portion of the City's right of way in the alleyway, which is more specifically described in **Exhibit "A"** and **Exhibit "B"** attached hereto, is hereby abandoned; and

**3.** As of the passing of this Ordinance, the alleyway being abandoned herein as a right of way in favor of City shall, in all respects, now become the responsibility of the fee simple owner(s) of said tract for all maintenance and upkeep.
