In accordance with provisions in our contract Amendment for Solid Waste Collection & Disposal with the City of Mineola under <u>RATES</u> please accept this letter as your required notification from Republic Services of the 3% rate adjustment. Commercial Handload rates will also reflect 3% on the matrix rate sheet. The effective date of said adjustment shall be July 1, 2024. Please note that <u>Commercial dumpster rates are not affected.</u>

This annual adjustment was approved at the execution of the current solid waste contract Amendment by council and will not require any further action with the exception of a new ordinance for new rates passed on to the City's customers.

ORDINANCE

AN ORDINANCE AMENDING SECTION 34-22 OF THE CODE OF ORDINANCES OF THE CITY OF MINEOLA, TEXAS,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MINEOLA, TEXAS, AS FOLLOWS:

Section 34-22 of the Code of Ordinances, City of Mineola, Texas, is hereby amended to read as follows, to-wit:

Section 34-22. Service rates - Schedule

(a) The rates for residential solid waste collection inside the city limits shall be eighteen dollars and sixty-five cents (\$20.34) per month for a residential dwelling and the solid waste shall be placed behind the curb or in the alley where accessible. This rate includes brush and leaf pick-up.

(b) The rate for residential solid waste collection outside the city limits shall be sixteen dollars and thirty-five cents (\$17.86) per month, and all regulations and definitions for inside the city limits shall also apply to customers outside the city limits. This rate does not include brush and leaf pick-up.

(c) The rates for commercial handload solid waste collection inside and outside the city limits shall be as follows:

(d) The rates for commercial cart service solid waste collection inside and outside the city limits shall be as follows:

The rates shall be effective for the July, 2024 billing period.
